Minutes

Mr. Hackett made a motion to approve the March 14, 2018 minutes as written. Mr. Rohrer seconded the motion. Motion carried 6-0-1 with Mr. Fullerton abstaining due to absence.

Plan Reviews

Stone Fence Ph. 2 14-03-FP2

Landis Farm Phase 3 addresses 22 duplexes and 13 single family homes.

Mr. Rohrer made a motion to recommend approval of the Landis Farm Phase 3 Final Plan subject to staff and engineer comments. Mr. Lehr seconded the motion. Motion carried 7-0.

Other Business

Mr. Beck stated that the township has received a Map and Text Amendment request from Traditions of America for the property located at 2686 State Road. The requests will be coming before the Planning Commission for recommendation to the Board of Supervisors.

Mr. Beck requested that the Planning Commission make a recommendation to the Board of Supervisors to deny Lidl's Final Land Development Plan due to the applicant failing to address all of the outstanding township engineer and township staff comments and subject to staff receiving a time extension letter from Lidl to extend the April 29, 2018 BOS action date. Mr. Beck requested the denial based on the fact that the 90-day date for BOS action is April 29th, and this would be the last PC meeting to send a recommendation to the BOS.

Mr. Rohrer made a motion to recommend denial of the LIDL plan subject to the BOS receiving a time extension prior to the next BOS meeting and the applicant's failure to address outstanding engineer and staff comments. Mr. Hackett seconded the motion. Motion carried 7-0.
